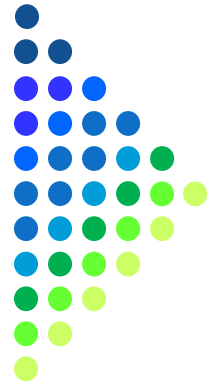

## Apply for a CPA Exam Scholarship

Need help paying for the CPA Exam? Apply for the AICPA Foundation's CPA Exam scholarship. This scholarship was created to assist current students and graduates who are CPA candidates with some of the costs associated with taking the CPA Exam. The AICPA Foundation CPA Exam scholarship reimburses up to \$1,500 for CPA Exam fees and exam preparatory courses.

Applicants must provide a copy of their Notice to Schedule (NTS) for at least one section of the CPA Exam and a copy of the receipt for payment of exam application fees. At least 50 extraordinary applicants will be paid up to \$1,500 in a lump sum to reimburse and assist with expenses for exam fees and CPA exam preparatory courses.

#### What is your first experience or favorite memory of your involvement with ARCPA?

#### Best advice for students about becoming a CPA, or taking the CPA Exam?

I've always told students that school doesn't teach you to be an accountant, but it does teach you how to think like an accountant. Practice is different than theory but the fundamentals and foundation you've learned will help you in the "real world". The numbers tell a story and it's our job as a CPA to help our clients understand that story.

For my younger colleagues I tell them to make sure they are committed and remain motivated when they are taking the CPA exam. As with anything, it takes a lot of will to finish one of the most difficult professional exams there is. But the reward and experience gained by passing that exam is invaluable.

#### Why did you become a CPA?

When I was younger, my family didn't always make the best financial decisions. The experiences that came out of that led me to be more conscious about money and business. So, in high school when we were asked to pick a profession we might want to go into, accounting resonated with me. I thought that if I understood accounting, then maybe I could help my family with those struggles. So, I made the decision then that I would become a CPA. To this day being a CPA is still about family and relationships for me.

#### Best advice for students about becoming a CPA, or taking the CPA Exam?

Start ASAP. Don't let your college study habits disappear before you get started on the exam.
