ARCPA Virtual Student Career Fair on Weds. September 22

Virtual career fairs are online events that allow employers and students to meet in virtual environments such as video chat rooms, and offer advantages to both students and employers! Students benefit by saving valuable time and can meet with potential employers without having to travel. Students can also avoid the awkward or intimidating feeling of having to walk into a crowded room full of strangers.

Arkansas Society of CPAs (ARCPA) will hold its **Student Career Fair (meet the firms)** on <u>Wednesday, September 22, as a virtual event by</u> <u>scheduled appointments between the hours of</u> <u>2:00 p.m. to 6:00 p.m.</u>

Students should familiarize themselves with the **Career Fair Plus website or app** in advance. If using the app for the event, students should download the Career Fair Plus app to their phone or device (from App store or Google Play) in preparation for the virtual fair and should view the demo to see how it works: <u>www.youtube.com/</u><u>watch?v=j5vKcuZj2ik</u>

The firm recruiters will set their appointment time slots. Once the appointment sign up period opens for students (on the morning of **September 8**), then students can upload their resume as a PDF and book appointment times to meet virtually with the firms (using the Career Fair Plus website or app). Appointment sign-ups will begin at 8:00 on the morning of September 8 and will be on a first-come, first-serve basis.

Students should keep checking back periodically to see if additional firms sign up between September 8 and the date of the event.

Post bachelors and junior and senior-level accounting majors at Arkansas' four-year public and private colleges and universities are invited to attend. Space for this online event is limited to the first 100 students who sign up.
