### DeGray Chapter Student Event

Members of the ARCPA DeGray Chapter met in Hot Springs on November 14, 2023 for their quarterly meeting and annual student night. Each year, the Chapter hosts students from area colleges for a pizza dinner and cash scholarship giveaway. 26 students from Ouachita Baptist University (OBU) in Arkadelphia and National Park College (NPC) in Hot Springs attended this year's event.

Chapter leaders collected approximately \$3,000 from chapter members and area businesses for the cash gifts. Several members also shared their career path stories as encouragement for the students to become a CPA. "It is very rewarding to meet these bright students and encourage them to go the distance and become a licensed CPA," said Marsha Moffitt, ARCPA Executive Director and CEO.

During the event, ARCPA Board Chair Rocky Goodman encouraged accounting students to get their CPA, noting that a CPA license can help them command a job over candidates who do not have a CPA license.. Harris Felton, with Hogan Taylor, LLP, spoke to students; Harris recently passed the CPA Exam and is currently working on his experience requirement to become licensed. DeGray Chapter member Jerry Dodd shared experiences about his 40+ year career as a CPA. DeGray Chapter Treasurer Jerry Edgin also shared how his CPA license helped to advance his career within one company, starting out as Controller, becoming a CFO, and now he serves as CEO. DeGray Chapter member Joe Patrico told students how his career path has led him to work in the banking industry.
